Application Deadline: Applications must be received no later than May 31, 2023

- 1. <u>Participation Fees:</u> There is no fee to participate, however the Festival requires a \$200 refundable deposit to hold a table space at the event, and that you provide the wine that will be poured by your winery for the Festival to sell as tastes during your assigned shift time. Any wine donations for raffles or contests will qualify you as an in-kind sponsor. Deposits are to be refunded upon final reconciliation at end of Festival. If a credit card is used, you give CAFI permission to charge the deposit to your card in the case of no-show.
- 2. <u>Vendor Entry Passes:</u> Vendors will receive four (4) entry passes per booth, per day. Additional discounted vendor passes good for both days, may be purchased at the cost of \$7.00 each.
- **3.** <u>Parking:</u> Space is extremely limited and Castroville Artichoke Festival, Inc. cannot guarantee that free parking spaces will be available to you. You are encouraged to arrive early on the days of the event in order to find free parking on Fairground Road. All other parking on the Fairgrounds during hours of operation will be for fee only. If you must enter grounds with, and wish to store a trailer or equipment hauler, please request a special entry/parking pass for this purpose from the Vendor Coordinator. A limited number of RV parking spaces may be available on the festival grounds, at the rate of \$70.00 per day. The RV parking fee covers arrival by no earlier than 1:00 p.m. on Friday June 9, 2023 and departure by no later than 6:00 p.m. on June 11, 2023. If you must arrive or depart before or after these times, prior written consent and approval must be obtained from the County of Monterey and payment in the amount of \$70.00 per additional day may be required or assessed by the County of Monterey at its sole discretion. For further information about RV space, please contact the Monterey County Fair & Event Center Administration Office at (831) 717-7167, or visit their website at www.montereycountyfair.com.
- 4. <u>Booth supplies</u>: Festival will supply a six-foot table covered with fresh linens each day. Water and ice will be supplied by Festival and Tasting Room staff as well as tasting glasses, water pitchers and dump buckets.
- 5. <u>Pours</u>: Vendors are asked to provide a 1-ounce portion of wine to attendees.
- 6. <u>Safety Statement</u>: Each vendor is cautioned to exercise care in the operations of his/her booth. An air of professionalism will be expected at all times.
- 7. <u>Hours of Operation</u>: Hours of festival operation shall be from 10:00 AM to 6:00 PM on June 10, 2023 and 10:00 AM to 5:00 PM on June 11, 2023. All vehicles must be unloaded and off the festival grounds no later than 9:00 AM each morning. Your table is required to be staffed at all times during your assigned shifts. The Wine Tasting Room will be open from 11:00 AM to 5:00 PM Saturday, and 11:00 AM to 4:00 PM Sunday.
- 8. <u>Set-Up/ Tear-Down</u>: Vendors may set up their booths on Friday, June 9, 2023 between the hours of 1:00 PM and 5:00 PM or on June 10, 2023 between the hours of 8:00 AM and 9:00 AM. All vehicles must be off festival grounds by 9:00 AM on June 10, 2023. Vendors are required to attend both days of the 63rd Annual Artichoke Festival. All vendors shall dismantle their booths and clean space commencing at 5:00 PM Sunday, June 11, 2023. Nothing is to be left on festival grounds.
- **9.** <u>Garbage</u>: The booth area must be clean and free of litter during the festival and when vacating the booth on Sunday. Failure to comply may disqualify you from future festivals.

- 10. <u>Animals</u>: No animals, except for service animals, are allowed on grounds during festival hours of operation. Pets or service animals will NOT be allowed inside Wine Tasting area.
- 11. <u>Resale License and ABC Wine Authorization</u>: Vendors are required to have a California Reseller's License and Wine Authorization from ABC if selling wine by the bottle or case, (this form can be downloaded off the ABC website). This is available from the California Department of Tax and Fee Administration at 111 E. Navajo Drive Suite 100, Salinas, CA 93901. Phone (831) 443-3000.
- 12. <u>Area of Sales:</u> Vendors may not conduct any sales outside the confines of their assigned booth. This pertains to the sale of bottles and cases. Tasting Room staff will assist wineries in the delivery of bottle and case sales to customers. NO ONE UNDER THE AGE OF 21 OR WHO IS NOT AFFILIATED WITH THE ARTICHOKE FESTIVAL WILL BE ALLOWED IN THE WINE TASTING ROOM.
- 13. <u>Tasting Supplies:</u> Vendors should have enough supplies to last each day through closing. Previous year supplies should be increased by approximately 5 to 10 percent to allow for growth of the festival. Vendors who fail to take reasonable steps to fulfill this responsibility will receive reduced priority in applying as Tasting Vendors in the future.
- 14. <u>Violation of Policy</u>: The above policies will be strictly enforced. Castroville Artichoke Festival, Inc. reserves the right to dismiss any vendor who does not adhere to these policies. **THE ABOVE RULES ARE FOR YOUR PROTECTION AND FOR THE BENEFIT OF ALL PARTICIPANTS**.
- **15.** <u>Workers Compensation Insurance:</u> Vendors are advised to carry Workers Compensation Insurance on any paid employees. This coverage is not provided by either Castroville Artichoke Festival, Inc. or Monterey County Fair & Event Center.
- 16. <u>City Business License:</u> All Vendors who will be selling bottles or cases are required to have a current License To Do Business through the City of Monterey. If Vendor does not already possess a current City of Monterey business license, Vendor must apply for and receive a temporary business license through the City of Monterey Revenue Division. If Vendor does not possess a valid and current business license, Vendor will not be selected for inclusion in the 63rd Annual Artichoke Festival. Vendors may apply online and pay for their temporary City Business License directly from the City of Monterey Revenue Office at: http://cmbuslic.ci.monterey.ca.us/businessLicenseApplication/ The fee for this permit will be assessed by the City of Monterey Revenue Dept. Castroville Artichoke Festival, Inc.'s inclusion of this link does not in any way imply or guarantee that the City of Monterey will issue the temporary business license applied for by Vendor.
- 17. <u>Policy Changes:</u> Castroville Artichoke Festival, Inc. also reserves the right to make changes in the above policy as necessary.
- **18.** <u>Wi-Fi/Internet:</u> Wi-Fi/Internet: Although cellphone service is good, wi-fi bandwidth is very limited at the fairgrounds. Please inquire with your vendor coordinator at set-up time if wi-fi internet access is absolutely necessary.
